**Canvass** - The Board members, with the help of Director Greene, compared results on two different reports to check for accuracy of results. The Board then signed the required abstract.



**Supplemental Absentee Review and Count** - Director Greene informed the Board that since their previous meeting on Election Day, the BOE had received 12 absentee by mail ballots. She explained that one ballot was spoiled, and one ballot was returned after the deadline. Each member of the Board viewed the two ballots that would not be counted. Then the Board worked together to review the other ten ballots to ensure they met all the needed requirements. All 10 ballots were approved unanimously.

Director Greene began inserting the approved ballots into the DS200. After all ballots were counted, she closed the polls and printed the results tape and had the Board sign it. The absentee abstract was then completed.

**Provisional Review and Count** - The Board was informed that the BOE had received thirty-four Provisionals during this election period. She explained that BOE staff had researched each Provisional. As a result of this research, seven were approved and thirty-seven were denied. All Board members reviewed the research results provided. Ms. Murrill, Chairperson of the Board, signed and marked whether the ballot would be counted or not. Seven ballots were counted all


together. Director Greene, after opening the polls for Provisionals, began feeding in the approved ballots. After closing the polls, the Board signed all required tapes printed from the DS200.




In total thirty-eight ballots were approved.




