Crisis intervention services are provided at any location in the community to reduce barriers to service delivery.</p> <p>Hope 4 NC Helpline - 855-587-3463 - This helpline is available 24 hours a day/ 7 days a week and connects North Carolinians to additional mental health and resilience supports that help them cope and build resilience during times of crisis.</p> <p>Hope 4 Healers Helpline - 919-226-2002 - This helpline provides mental health and resilience support for health care professionals, emergency medical specialists, first responders, other staff who work in health care settings and their families throughout the state who are experiencing stress from being on the front lines of the state's COVID-19 response. Hope4Healers is also available 24 hours per day, seven days a week for people to reach out for support; they will be contacted quickly by a licensed mental health professional for follow-up.</p> <p>NC 211 - Dial 2 1 1 to access information and referral services for families or individuals on obtaining free and confidential information regarding health and human services resources within their community. NC 2-1-1 operates 24 hours a day, seven days a week, 365 days a year and resources are available in most languages.</p>

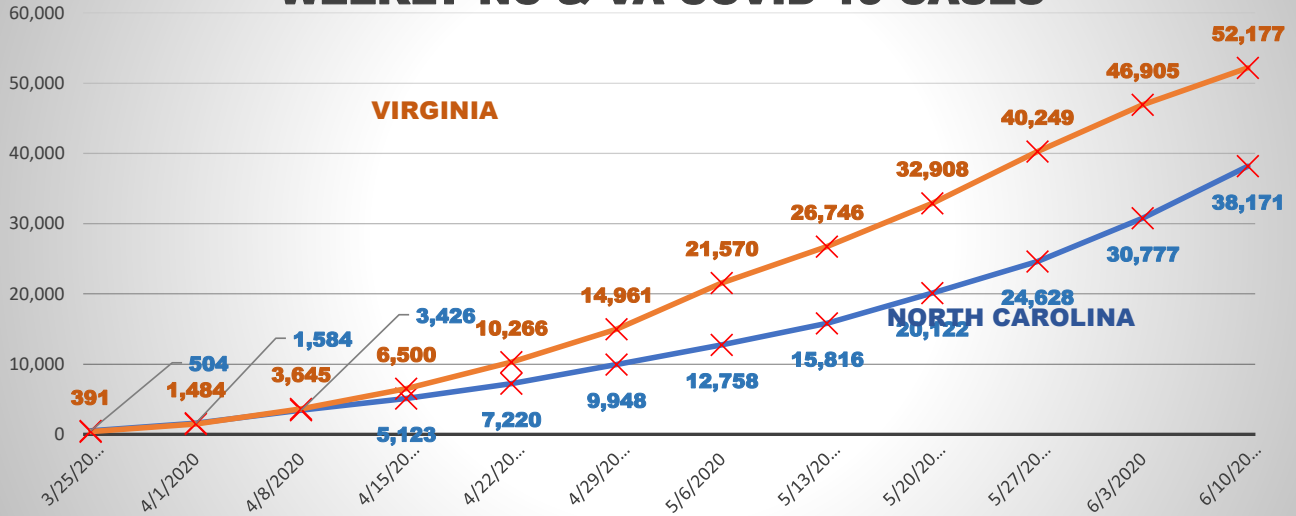

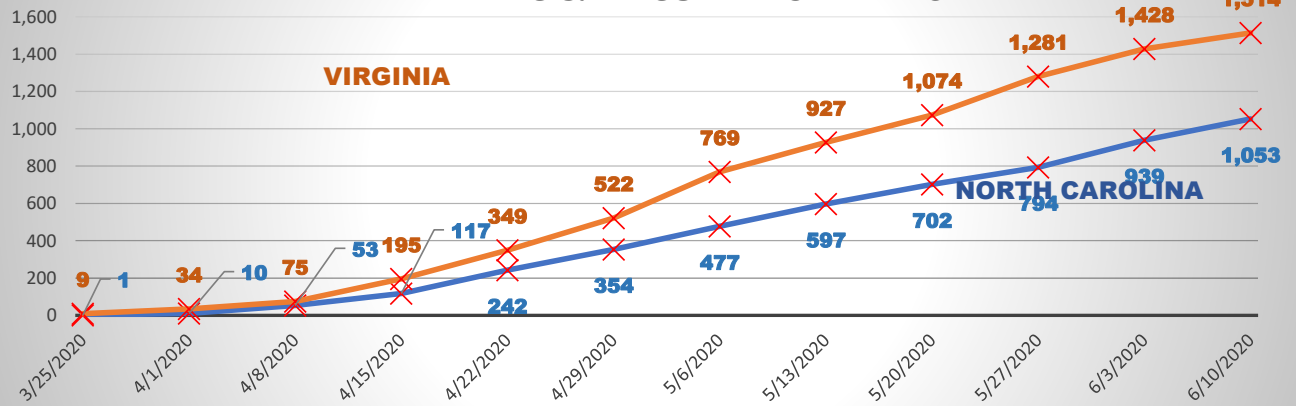
