**PERQUIMANS COUNTY, TOWN OF HERTFORD, TOWN OF WINFALL
STATE OF EMERGENCY ORDINANCE**

WHEREAS, the Coastal Counties of Northeastern North Carolina are immediately threatened by Tropical Storm Isaias; and

WHEREAS, conditions exist which could endanger the lives, safety, health and welfare of the people residing within Perquimans County, Hertford and Winfall; and

WHEREAS, conditions exist which could threaten damage to or destruction of property; and

WHEREAS, persons living and/or working in low lying areas of the County, manufactured homes and substandard housing are especially at risk for high water and dangerous winds.

WHEREAS, under North Carolina G.S. 166A and 36A, Chapter 14, the Emergency Services Director is authorized to take whatever steps are considered necessary for the protection of citizens within Perquimans County; and

WHEREAS, the Mayors of the Town of Hertford and the Town of Winfall have declared a State of Emergency for the towns and request to be part of this State of Emergency Ordinance; and

WHEREAS, additional instructions may be issued if considered necessary.

BY THIS PROCLAMATION, Perquimans County, the Town of Hertford, and the Town of Winfall is hereby declared to be in a State of Emergency effective 6:00 p.m. EST, Monday, August 3, 2020.






