ALBEMARLE REGIONAL HEALTH SERVICES PROVIDES UPDATE ON REGIONAL VACCINE CLINICS Updated COVID-19 vaccine counts, cases, and outbreaks

Elizabeth City, NC – Albemarle Regional Health Services (ARHS) is providing updated information on COVID-19 vaccines, lab confirmed positive COVID-19 cases, and facility outbreaks as of 1 p.m. Friday, October 22, 2021 in addition to the weekly surveillance report (attached).

"The FDA and CDC have officially granted authorization for COVID-19 booster doses of Moderna and Johnson and Johnson," states R. Battle Betts, Jr., MPA, ARHS Health Director. "We are now working to update our local standing orders and finalize local dispensing plans. ARHS is preparing for the expansion of our vaccine campaign and will announce details next week including who is eligible, along with clinic and appointment information; we have plenty of vaccine to meet the demand. In addition, we are continuing to wait for approvals of the Pfizer vaccine for children 5-11 years of age. Widespread vaccination is a critical tool to help stop the pandemic."

ARHS is continuing to accept vaccine appointments for Moderna and Pfizer, along with Johnson and Johnson. Appointments will be available to residents of the eight county region who are 12 and older. Appointments for third dose vaccines for moderately to severely immunocompromised individuals living in the eight-county region are being accepted for Moderna and Pfizer. Booster doses for Pfizer are also available.

"At this stage in the pandemic, and while weighing your options for vaccination along with those of your children, it is important to remember the purpose of a vaccine," said Betts. "While vaccines are crucial for protection and prevention against illness in an individual, historically, they are so much more. When vaccination rates are high, additional protection is offered to the entire community, making it difficult for the virus to spread. When we don't have good levels of community protection, we see outbreaks and will continue to see changes in the virus that make the vaccine less protective for individuals as well. This safe and effective vaccine is a key to a brighter future."

COVID-19 Outbreaks in Congregate Living Facilities

The outbreak at Brian Center in Hertford, NC has resolved.

COVID-19 testing is still available by appointments at the local health departments across the region. Tests will be completed through a curbside screening clinic. To schedule an appointment call your local health department directly.

ARHS is collaborating with OptumServe to provide additional, no-cost COVID-19 testing sites in Bertie, Chowan, Hertford, and Pasquotank counties. The Pasquotank site is offering rapid tests along with PCR tests. All other Optum sites offer PCR only. Typically testing is available most days of the week however, times and days may change so please call or check the website prior to going to a site. You may check availability and register to make an appointment for testing by visiting <u>https://lhi.care/covidtesting</u> or by calling (877) 562-4850.

ARHS is continuing to ask our community citizens to be mindful in practicing preventive and safety measures to prevent the spread of COVID-19. Please remember these precautions:

- Avoid close contact with people who are sick.
- Avoid touching your eyes, nose, and mouth.
- Stay home when you are sick.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
- Clean and disinfect frequently touched objects and surfaces using a regular household cleaning spray or wipe.
- Wash your hands often with soap and water for at least 20 seconds, especially after going to the bathroom; before eating; and after blowing your nose, coughing, or sneezing. If soap and water are not readily available, use an alcohol-based hand sanitizer with at least 60% alcohol.
- Practice social distancing; stay at least six feet away from others, avoid unnecessary travel, avoid handshakes, hugs and other close contact.
- Wear a cloth face covering in public.
- Get vaccinated.
