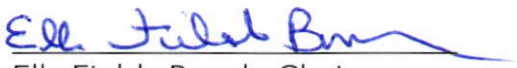
Upon a motion made by Member Butler and second by Member Murrill, the Board unanimously voted to approve the agenda as presented.

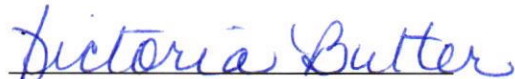

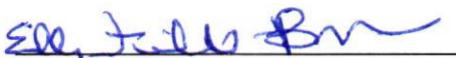
