Trainings Dates are Posted...

Mandatory Auxin Training...All persons planning to apply dicamba (Engenia, FeXapan, Tavium, or XtendiMax to Xtend cotton or soybeans or 2,4-D (Enlist Duo or Enlist One) to Enlist cotton or soybeans must complete the mandatory training Auxin Herbicides - Best Management Practices prior to use in 2020.

The two options in this area include: January 21, 2020 - 2:00-3:00 pm - Leon Nixon Catering (749 Virginia Rd, Edenton, NC 27932) or February 4, 2020 - 3:00-4:00 pm - Currituck Extension Office (120 Community Way, Barco, NC 27917)

All applicators of the dicamba products must be certified or licensed commercial applicators.

If applicators are not licensed, they may still attend the mandatory auxin training to get credit but also must attend the Private Applicators Testing that will be held at the Pasquotank Extension Office (1209 McPherson St, Elizabeth City, NC 27909) on January 27th to obtain a license.

Watermelon Trial Data Shows What's Best

In the 2019 growing season, a watermelon variety trial was conducted with a grower in Rocky Hock in Chowan County. Fifteen commercially available watermelon varieties were planted and data was collected on size, sugar content, color, yield, and other qualities. The goal of this trial was to help growers determine which watermelon cultivars are best suited for this area. The results of this trial are now available

Scams Have Been Reported in NC

In the last few days, NCDOI has had reports of phone calls with the Caller ID listed as "Senior Center" but the number is unavailable. The callers are saying they are conducting a Medicare survey and are asking for personal information or asking if those they have called if they have received their new 2020 Medicare card.

"If someone is calling, claiming to be from Medicare and asking for your Social Security number or bank information, hang up, it's a scam," said Commissioner Causey. "First, Medicare won't call you. Second, Medicare will never ask for your Social Security number or bank information," he added.

If someone is threatening to cancel your benefits if you don't give up information or money, report it to the Department's Seniors' Health Insurance Information Program or SHIIP or the N.C. Senior Medicare Patrol at 1-855-408-1212.
